### AFFIDAVIT

I Mr. Bebilal Kesharmal Sancheti, S/o Kesharmal Surajmal Sancheti, aged about 83 years, Chairperson of the Trust 'Shri Neminath Jain Bramhacharyashram' running the school Late Shri Dhanrajji

**Mishrilalji Bhansali English Medium School At- Neminagar, Chandwad, Taluka Chandwad District- Nashik Maharashtra Pin- 423101, do hereby solemnly affirm and declare that-**

01. That “**Shri Neminath Jain Bramhacharyashram**” is registered under the **Bombay Public Trust Act 1950 (Bom XXIX of 1950)**.
02. That the “**Shri Neminath Jain Bramhacharyashram**” is of Non-proprietary Character.
03. That no member of the School Management Committee is related to each other.
04. That the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
05. That I ensure that the school gets proper land, building equipment, furniture and qualified staff at least as per norms of the Board.
06. That no part of income from the institution shall be diverted to any individual in the **registered under the Bombay Public Trust Act 1950 (Bom XXIX of 1950)**, School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school.

07. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.

08. That the school will not open classes under CBSE pattern particularly class IX and will not use CBSE name in any manner without obtaining affiliation.

09. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

10. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.

11. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

12. That the school will ensure that all required infrastructure is available with the school before starting classes.

13. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.




14. That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.

That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the post affiliation conditions contained in affiliation byelaws along with general rules.

20. The said institution has the sufficient space for play ground.


21. I have to file this affidavit before concern authority in support of the above said fact.
