### **Staff and faculty**

A complaint of discrimination or sexual harassment may be lodged by the victim or a third party. A written complaint may be addressed to the Chairman of the committee. If the complaint is made to any of the Committee members, they may forward it to the Chairman of the Committee against Sexual Harassment. Here it should be noted that according to the Supreme Court guideline Sexual harassment can be defined as "unwelcome" sexually determined behavior (whether directly or by implication) as:

- Physical contact and advances;
- Demand or request for sexual favors;
- Sexually colored remarks;
- Allow children to engage in sexually provocative games with each other
- Showing pornography; and
- Other unwelcome physical, verbal or non-verbal conduct of a sexual nature.

- Other unwelcome physical, verbal or non – verbal conduct by the committee:

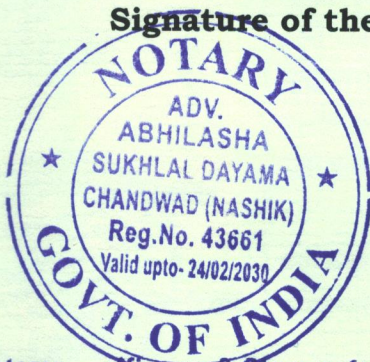


**The following is sexual harassment and is covered by the committee:**

1. Eve-teasing, Unsavory remarks, Innuendos and taunts,
2. Jokes causing or likely to cause awkwardness or embarrassment,
3. Gender based insults or sexist remarks,
4. Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls).
5. Touching or brushing against any part of the body and the like,
6. Displaying pornographic or offensive or derogatory pictures, cartoons, or sayings.
7. Forcible physical touch or molestation
8. Physical confinement against one's will and any other act likely to violate one's privacy.
