

MAGIC OF HOMEOPATHY - FORMATION OF WELL-FUNCTIONING SECOND UMBILICAL ARTERY IN A CASE OF ISOLATED SINGLE UMBILICAL ARTERY (SUA) DETECTED IN SECOND TRIMESTER IN A MULTI-GRAVIDA WITH BAD OBSTETRIC HISTORY (BOH).

Abstract:

A 29-year-old anxious multi-gravida, with history of repeated idiopathic Intra-Uterine Fetal Deaths, came with ultrasonography findings of Single Umbilical Artery (SUA) at 20 weeks 1 day of gestation in her fourth pregnancy. On further investigation it was found to be a case of Isolated SUA (single umbilical artery in the absence of chromosomal abnormalities and structural abnormalities. Out of her last three eventful pregnancies, her third pregnancy was saved by our homoeopathic treatment, though the neonate had a cyst in brain which required surgery. This time again she came with a hope to save this fetus from any unforeseen climax. With proper anti-miasmatic homoeopathic treatment, by the third trimester, a wellfunctioning second umbilical artery had developed in the umbilical cord as detected in the ultrasonography findings. The patient delivered a normal healthy baby at full term without any co-morbidities.

Introduction:

Homeopathy in Gynaecology and Obstetrics is not much explored and many homoeopaths yet underestimate the power of Homoeopathy in cases like Bad Obstetric History (BOH) and Single Umbilical Artery (SUA). Isolated SUA is the absence of chromosomal abnormalities and structural abnormalities in vitro. Fetuses and neonates with isolated SUAs have increased rates of prematurity, growth restriction and adverse neonatal outcomes. In this case we have explored the role of homeopathy in vitro where modern medicine has limited role to play and a two-vesselled umbilical cord turned into a

well-functional three-vesselled cord within a span of 2 months in a lady with strong history of BOH.

Case-History:

A 29-year-old anxious multi-gravida from Burhanpur, with history of repeated idiopathic Intra-Uterine Fetal Deaths, came with ultrasonography findings of Single Umbilical Artery (SUA) at 20 weeks 1 day of gestation in her fourth pregnancy. On further investigation it was found to be a case of Isolated SUA.

Obs/H: G4 P2 A1 L1 LMP: 24/5/2021 Mean gestational age by USG - 19 weeks 4 days & by LMP-20 weeks 1 day

USG stated: The umbilical cord is two vesselled, the fetal doppler screening in all vital vessels are normal

As per the history of patient,

1 pregnancy - IUFD in last month of pregnancy

2ND pregnancy – fetal death on second day after birth

3^{nt} pregnancy — Patient took homeopathic medicines from me to save the child, we succeeded partially – baby was born with cyst in brain which required brain surgery, now baby is fine at age 3 years.

4th pregnancy – umbilical cord has two vessels though everything is fine. But they visited me for same to save the child.

Apart from morning sickness during first trimester, no any other major complaints.



Case Analysis:

In this particular case, we see a strong pre-disposition of similar complaints appearing again and again at same time i.e. during pregnancy.

In her previous pregnancy, we had given her constitutional remedy which helped partially – we could save the fetus but it was born with a cyst in the brain and a surgery was needed. This means that inspite of prescribing well-selected remedy, the desired result was not found. Hence there must be miasmatic dominance in the background which is not allowing complete cure. Recurrence of complaints in all 3 pregnancies indicates sycosis dominance. So according to this observation anti-miasmatic medicine was prescribed 2.

Since we didn't have fully developed symptomatology, we used Boger's approach to find the remedy.

Totality of symptoms:

- 1. Abortion in last month of pregnancy
- Sycosis
- Cleanliness mania
- 4. Thermals: Hot

Remedy selection:

Out of Medorrhinum, Thuja occidentalis and Natrum sulph which are known to be the king of anti-miasmatic remedies, Thuja occidentalis was selected because of its profound affection on female reproductive system.

Potency selection:

Susceptibility of the patient is moderate hence moderate potency.

The Remedy:

Thuja occidentalis 200 single dose followed by Sac Lac three times a day for a month was given on the day of case-taking i.e. 12/10/2021. Patient was called for follow-ups every month.

In all follow-ups, sac lac three times a day was prescribed.

Follow-up:

At the end of 3 months, gynaecologist advised third trimester USG to find about the development of a third well-functional umbilical artery. (See USG Report) Final follow-up:

On 23/02/2022, the patient delivered a healthy baby vaginally at full term of birth weight 3.2kgs.



Conclusion:

By this case, we learnt the importance of knowledge of miasms in understanding and analysis of such cases. Being a one-sided disease case as per the Hahnemannian classification of diseases, it was difficult to get the desired result. If not for the knowledge of miasms and proper application of the same, probably this pregnancy would have turned out to be eventful too. Also, rather than thinking about whether homeopathy would work in any particular case, we should think of such cases as a challenge and justify the application of aphorism of knowledges of physician3.

STUDY OF MERCURY GROUP IN CASE OF INFLAMMATORY CONDITIONS WITH SPECIAL EMPHASIS ON MERC SOL

Abstract:

Inflammation is part of the body's defense mechanism. It is the process by which the immune system recognizes and removes harmful and foreign stimuli and begins the healing process. Inflammation can be either acute or chronic. Mercury group has a prospective role of treatment in inflammatory condition as because homoeopathic treatment is not only based on the disease symptoms alone, but also on person's physiological and emotional symptoms. In homeopathy, Merc sol can treat inflammatory condition by directing overactive immune system. They decrease joint inflammation and symptoms including swelling, pain and stiffness of joints.

In all the selected cases, psora is in the background. 10 cases were selected out of which 5 were showing improvement 2 were showing progressive improvement, 3 were showing no improvement.

Introduction:

Inflammation (from Latin: inflammatio part of the complex biological response of body tissues to harmful stimuli, such as pathogens, damaged cells, or irritants, and is a protective response involving immune cells, blood vessels, and molecular mediators. The function of inflammation is to eliminate the initial cause of cell injury, clear out necrotic cells and tissues damaged from the original insult and the inflammatory process, and initiate tissue repair.

Inflammation: -

Definition:

Inflammation is defined as the local response of living mammalian tissue to injury due to any agent.

Body defense reaction eliminate or limit the spread of injurious agent.

Types of inflammation: -

Mainly of 2 types i.e., acute and chronic

- 1. Acute Inflammation
- a. Short duration
- Represents the early body reaction-followed by healing.
- 2. Chronic inflammation
- longer duration.
- b. causative agent of acute inflamm-ation persists for a long time.
- 3. Another variant, Chronic active inflamution.

Disease Associated with Inflammation : Joint diseases:

Rheumatoid arthritis (inflammation of the joint synovial membranes), gouty arthritis, psoriatic arthritis, bursitis, and ankylosing spondylitis (inflammation of the vertebrae, ligaments, and the sacroiliac joints)



Allergies: Asthma and hay fever. Asthma involves inflammation of the airways. Life threatening inflammation or anaphylaxis that affects the whole body may occur due to an allergic reaction to drugs, or insect bites.

Heart disease: Chronic inflammation has been linked to diseases of heart and blood vessels. The buildup of fatty, cholesterol-rich plaque in blood vessels causes chemicals to be released from the white blood cells. These chemicals respond to the fatty plaque as foreign invaders. Inflamed blood vessels and fatty plaques can cause blockages and blood clots, which may lead to heart attacks.

Diabetes: This endocrine/metabolic disease may result when there is destruction of the endocrine cells of the pancreas (islets) due to autoimmune inflammation with a reduction or lack of insulin secretion from the islets resulting in high blood sugar levels (diabetes).

Bone disease: Chronic inflammation is associated with increased bone loss and lack of new bone formation. Also, inflammation in the gut can decrease the absorption of nutrients that are important to bone health, like calcium and vitamin D.

Skin diseases: Acne, boils, lupus, psoriasis, and dermatitis.

Study of Mercury Group: -

- Mercury, is a chalkophilic element in the earth characterized by strong affinity for Sulphur. It appears predominantly as red cinnabar (HgS) in earth and is obtain from it by roasting
- Mercury once ingested is mobilised by Sulphur and excreted. Its chemical action on the protein compounds of organisms is affected through the Sulphur containing group. Mercury shows great tendency to the formation of complex compound.
- Mercury is the only elemental metal which is liquid at room temperature.

Important Remedies :

- Mercurius Solubilis- contains ammonia &nitrate (Hg+NH4+NO3)
- Mercurius- hydrargyrum /merc vivus- quick silver
- Mercurius corrosivus- corrosive sublimate
- 4. Mercurius dulcis- calomel
- Mercurius iodatus flavus- Merc proto iodatus- Iodide of Hg
- Mercurius biniodatus- Merc iodatusruber
- Mercurius sulphuricus- Merc-sul

Common Traits and Group Characteristics:

Sphere of action: All mercury remedies mainly acts on glands and bones they also have mark action

On central nervous system. Other important sphere of action of mercury group are salivary gland mucous membrane, skin, lymph nodes, periosteum, synovial and serous membranes, kidney (tubules etc.)

Constitution:

Mercury group Remedies predominantly cover syphilitic affection. They all show mainly lymphatic constitution in many remedies of this group there is history of syphilis in past or in family. They are very much slow in action.

Mental Generals:

- All the mercury remedies show slow mental activity.
- Weakness of memory.
- Mercury group show reduce will power or no will power.
- They also show less confidence and always show fear about their work and activities.

General Features : -

- Mercury Group remedies show metallic taste in mouth.
- Tremors are basic characteristic of this group.
- Most of the complaints of this group aggravated at night and during perspiration.
- They all show tendency of pus formation or suppuration along with much offensiveness.

Particular Complaints and Group Characteristics: -

- Some of the particular complaints of mercury group remedies are tremors, rheumatic pains in joints and bones, eczema, induration of glands, ulcers.
- Mercury group remedies are found very much effective, very commonly in clinical conditions like Hemorrhagic disorders, otitis media, anemia, catarrh, aphthae, dysentery, tonsillitis.

Source of Data: -Clinical cases for study were taken from Homoeopathic college OPD.



Methods of Collection: - Including both males and females Above 15-60 years.

Study Duration: 1 year Selection of samples:

Clinical cases where Merc sol remedy is indicated were selected.

Sample Size:

10 OPD patients of various age groups out of which 7 were males and 3 were females.

Inclusive and Exclusive Criteria:

Inclusive Criteria:

- Cases of age group 15-60 years were included.
- Patient who were willing to given consent for study were included.

Exclusive Criteria:


- Patient below the age group of 0-15 years and above 60 years were excluded.
- Cases with complications and case of complex disease were excluded.
- Patient who were not willing to give consent for study were excluded.

Observation and Result:

In this systemic review we present information relating to the effectiveness and safety of the following interventions: that were homoeopathic remedy — Merc sol which was given in single dose 30 to 200 potency, according to its duration of action and sphere of action.



SCOPE OF BOGER BOENNINGHAUSEN'S CHARACTERISTICS AND REPERTORY IN THE SELECTIONS OF MEDICINE IN COMMON ACUTE SURGICAL COMPLAINTS

ABSTRACT:

Background - Boger Boenninghausen's Characteristics & Repertory (BBCR) has more clinical utility in cases having marked modalities, concomitants, pathological and objective symptoms. The acute surgical cases are common in different ages where the modern therapy included firstly conservative followed by surgery but the cases are observed where the reappearance of the disease in virulent form occurs. Rubrics related to pathology including constitutions, diathesis that can be considered as one of the causes of the manifestations shown in this repertory.Hence, BBCR is used to analyse the clinical applicability in common acute surgical complaints.

Materials & Methods - A case series study was adopted to assess the clinical utility of BBCR in cases of Abscess, acute appendicitis, acute tonsillitis and renal stone. Total 30 patients were enrolled in this study.

Results:

5 cases were partially cured 25 cases showed marked improvement. Nux Vomica, Sulphur, Belladonna, Bryonia alba and Mercurius were commonly prescribed remedies in markedly improved cases.

Conclusion - The study showed significant improvement in common acute surgical cases by using BBCR.

INTRODUCTION

Boger Boenninghausen's Characteristics Repertory was created by Dr Cyrus Maxwell Boger. The main philosophy of BBCR is based on Doctrine of complete symptoms and concomitants, Doctrine of pathological generals, Doctrine of causation and time, clinical rubrics, evaluation of remedies, fever totality and concordances.

Different types of constitutions and diathesis with group of remedies are available. Pathological generals tell the state of the whole body and its changes in relation to the constitution which help to concentrate on more concrete changes to select the Simillimum. Dr. Boger also gave importance to causation and general modalities followed by general sensations which hold the key in the remedy as well as in the person.

The common acute surgical complaints are those complaints which need immediate surgery. There are several complaints which are acute surgical but here I have selected only four complaints that are Abscesses, appendicitis, tonsillitis, and renal stones.

The acute surgical cases are common in different ages where the modern therapy included firstly conservative followed by surgery but the cases are observed where the reappearance of the disease in virulent form occurs.

According to modern system of medicine, the acute surgical cases are those in which one requires immediate surgery. They advise to do surgery as soon as they diagnose the case in spite of knowing the lots of complications of surgery. According to them, there is no other treatment other than the surgery. But there is good role of homoeopathy in treating these cases. Here I want to show how the Boger Boenninghausen's Characteristics and Repertory is useful in finding out the similimum for the common acute surgical complaints.

In our homoeopathy, there are several medicines through which we can treat these types of cases after prescribing according to the totality of symptoms and individualization. The constitution also plays an important role in prescribing homoeopathic medicine and when we prescribe medicine constitutionally, the patient easily gets rid of the prominent miasm because of which he is suffering from the disease. By treating these surgical cases after selecting medicine from the repertory Boger Boenninghausen's Characteristics and Repertory, we can



- Reduce the postoperative complications and can lengthen the life of a patient.
- Minimize the recurrent attacks with the help of homoeopathic medicines.
- Increase the immunity of the patient.
- Other ailments can also be cured with the help of constitutional medicine.

In this study, the constitutional approach to treat the manifestations of gout has shown the significant utility of BBCR on pathological ground as well.

AIM AND OBJECTIVES:

- To study clinical features and complications of common acute surgical cases like abscesses, acute tonsillitis, acute appendicitis, and renal calculi.
- To try and give relief to the patients suffering from common acute surgical complaints.
- To understand the limitation of modern therapies including surgery.
- To know the effect of other therapies in this aspect.
- To review the published literature on the management of abscesses, acute tonsillitis, acute appendicitis, and renal stone.
- To establish scope of Homoeopathic Medicines in the management of common acute surgical cases abscesses, acute tonsillitis, acute appendicitis, renal calculi.
- To establish the scope of Boger Boenninghausen's characteristics and Repertory in the selection of medicine for the abscesses, acute tonsillitis, acute appendicitis, renal calculi.

STUDYTOPIC:

An abscess is a collection of pus. It is of three type pyogenic, pyaemic and cold abscess. These abscesses cause great discomfort to the because of this the patient suffers from fever, pain, swelling, unable to the do the movement of the particular part where the abscess occur. The pus collected in the area has to be drained by giving incision in the abscess. This can be only done by surgery hence it is called a surgical case.

An acute appendicitis is a condition in which an appendix is inflamed and causes great discomfort to the patient such as severe agonizing pain in the abdomen, nausea, vomiting, and fever. The appendix is called as an vestigial organ. The pain is so unbearable that the surgeon always think to remove this

organ and they think that after removing this, the patient will get immediate relief in spite of knowing the variable complications of appendicectomy.

Tonsillitis is a condition in which inflammation of the tonsils occur. These may be acute or chronic. The symptoms of the tonsillitis are rawness in the throat, difficulty in deglutition and fever etc. These symptoms are getting worse unless and until we do not treat them properly. In such cases, the symptoms are so worse that surgeons think that tonsillectomy is the only right choice instead of knowing the several complications of tonsillectomy.

Renal stone is a condition in which there is formation of stones in the kidney. These may acute or chronic. The symptoms of the renal colic depend upon the size of the stone lodged. The symptoms of the renal stone are pain and discomfort in the kidney region, difficulty in passing urine if stones come in the ureter or urethra. The variations in the quality of urine occur due to stone. A physician or surgeon can treat it with the help of conser-vative therapy but they suggest operation for removal of the stones. But there are more chances of recurrence after doing the operation.

Homoeopathy is a science based on old and well proven traditions of treating *like with like*. Homoeopathy believes in the art of individualization and the concept of totality.

As far as the individual patient is concerned, it is still the quality of individual caring and understanding, the personality and sensitivity of the doctor, and the art of listening and communication, which are most important and most appreciated. Nevertheless the process of understanding, openness and communication is still painfully slow, particularly within the specialization of the medical profession. The care of and responsibility for the patient is often lost in the division of medicine into sub-specialization, and it is impossible to get any adequate facts at all about diagnosis of treatment without creating a fuss.

Homoeopathy overcomes all these problems, as there are no specialty branches, which divide the patient into parts, but on contrary every patient is understood and studies as a whole.

Homeopathy does not cure by finding a substitute or making another disease – the



disease of the doctor – but it simply removes the disease and leaves the constitution, the entire, better for the loss. It does not relieve pain or infection at the cost of the constitution. It does not relieve the tonsillitis at the cost of causing colitis or vaginitis. Whatever the limitations of homoeopathy it never makes the patient worse.

So here I want to treat the common acute surgical cases by finding out the similimum with the help of homoeopathy by using BBCR. To do this, I have taken 30 cases of different acute surgical cases, studied them properly i.e. their clinical features, signs, special investigations, complications, differential diagnosis etc. and after complete homoeopathic case taking advised by our master Dr. Hahnemann is After case taking, the analysis and evaluation of symptoms is done and reportorial totality is made. Then with the help of reportorial analysis, the group of remedies is found and after consulting Materia Medica, single medicine with proper dose is prescribed and result has been observed.

MATERIALS AND METHODS: Planning And Source Of Data:

A prospective study of 30 cases having acute surgical complaints was carried out between May 2008 to May 2009 at my clinic as well as cases from Shri. R.P. Chordiya Hospital Chandwad to see the efficacy of homoeopathic medicine in treating common acute surgical complaints. The cases obtained from different ages, occupation, body built, socioeconomic status, habits were taken into consideration during this period.

Selection of Patients:

Patients exhibiting signs and symptoms indicative of surgery were included in this study.

The symptoms, signs and laboratory findings were followed for diagnosis of the cases. This is done not only to support the diagnosis but also to rule out any complication. METHODOLOGY:

Case Recording

One standard case recording schema and a special questionnaire was maintained for keeping the clinical profile of the patients. This format was prepared according to the homoeopathic method of case taking, keeping the diagnostic aspects. The schema incorporates the biodata as well as other

specific information about the patients including their age, religion, occupation, addiction, habitat, habits, their presenting features, past/personal/family histories. physical/mental generals, physical examination findings etc. it also includes data of routine and special investigations done to confirm the diagnosis. The format also records the details of treatment given with, medicine, potency, repetition, schedule diet and advice and details of follow up till the end of treatment and finally results/remarks if any.

Diagnostic Criteria

The diagnosis of the patients was made mainly on history, the symptoms and signs of acute surgical complaints such as abscesses, appendicitis, tonsillitis, and renal stones.

Inclusion Criteria:

Most of the cases of common acute surgical complaints are children and young ones though adult cases were taken into consideration.

Exclusive Criteria:

- Other systemic complications
- Diseases affecting other than abscesses, appendicitis, tonsillitis and renal stones.

Selection And Administration Of Medicine

Medicine was given on the basis of law of similar and concept of individualization. Potency selection was based on the rules of homoeopathic posology

Routes OF Administration

Medicines were administered orally.


Follow-up Criteria:

Patients with complete relief of symptoms with the remedy but relapse of similar complaints within 6 months of time span will be considered as recurrence.



SUMMARY AND CONCLUSION

The treatment of common acute surgical complaints is only surgery according to modern system of medicine. Sometimes due to low socioeconomic status the patients are unable to pay the required fee for the surgery and if these conditions are not treated the patient will become uncomfortable and several complications will occur and sometimes in conditions such as appendicitis the patient die also. Though, it is very common conditions, but due to afraid of operation the people fear to seek advice of the physician and because of these, the condition of the patient will deteriorate and cause complications in their body. If they consult a surgeon for these conditions, they advise them to do surgery immediately.

To study these common acute surgical cases, the 30 patients suffering from these types of diseases were administered various homoeopathic medicines to explore the effectiveness of the homoeopathic medicines.

The patients were divided into 4 groups. Group I - Acute tonsillitis. Group II -Abscesses, Group III - Renal stone, and Group IV - Acute appendicitis. All these four groups were administered acute as well as chronic deep constitutional medicines. The medicines were prescribed empirically on oral route. The medicines were prescribed in the form of potencies; the dose was 4-5 pills at a time. Depending upon the severity of the cases the dose was repeated two to three times a day. Most of the times the dose was administered in water doses, every half an hour to one hour, every two hourly and four hourly in acute Repetition was done till some cases. subjective effect observed.

Total 30 cases were treated. The end result found to be positive and encouraging. Among thirty cases 25 cases were completely cured while 5 cases were partially cured. Though all the potencies are effective but positive response was more with medium and high potencies. Negative response was more



in cases of elder ones. The positive response was more in children.

The result obtained from this study is encouraging. So the most outstanding feature of this study was

- Homoeopathic medicines are effective in the treatment of common acute surgical complaints such as abscesses, acute tonsillitis, acute appendicitis, and renal stone.
- More effective in children when compare to the elder ones.
- Homoeopathic medicines play an important role in treating surgical cases as avoiding dangerous complications of surgery.
- 4. All 30 cases were repertorise with the help of Boger Boenninghausen's Characteristics and Repertory. This repertory is very useful in treating acute cases.

In all these common acute surgical cases, not only the location is important but also the sensation, modalities, concomitantsand physical and mental generals are important as these help in selecting the proper homoeopathic medicines.

Homoeopathic medicines have relieved the symptoms of common acute surgical complaints in a considerably less time. Compared to modern system of medicine, our medicines are very much cost effective and provide relief for a longer time.

The study has also shown that most of the cases are relieved and had no recurrence where as with surgery the recurrence is high and it reveal that homoeopathic medicines strengthen one's defense mechanism to fight off with the condition.

The human body is a perfect machine made self-sufficient by the creator, it has hot computers to take decisions and chemical factories in the form of glands to produce chemicals etc. required for proper working of this machine. The human body has primarily two systems that are defensive and reparative. Homoeopathic medicines help in strengthening these both mechanisms.

Through this study it was found that common acute surgical complaints such as tonsillitis and appendicitis are more common in young children and abscesses and renal stone can occur at any age. This study also concludes that medicines more useful in abscesses are Arsenic, Sulphur, China, Bryonia, in acute appendicitis are Arsenic, Belladonna, Carbo Veg, China, Nux Vomica, Phosphorus, Pulsatilla, Sepia, Sulphur in tonsillitis are Belladonna, Bryonia, Ignatia, Lachesis, Mercurius, Nux Vomica, Rhus Tox, Sepia, and renal stones are Bryonia, Lycopodium, Mercurius, Nux Vomica and Sulphur.

Every new case we get is a different puzzle to solve and that's the beauty and challenging part of homoeopathy. Homoeopathy cannot stand without the pillar of individualization and this was again confirmed through this small study. Homoeopathic medicines when given on the basis of symptom similarity and on the principle of individualization can soothe any discomfortable condition and give rapid, gentle and permanent restoration of health.

Each is a unique individual, of unique heredity, of unique environment, of unique biochemical structure and unique mental background and so homoeopathic medicines are given on the tailor-made approach where as allopathic medicines are given on readymade approach and so homoeopathic medicines can meet the requirements of each unique individual properly.

These may be single, multiple, smooth or cauliflower like and are generally treated by applying medicine externally Or surgical excision procedure. Warts are classified under one sided disease as external local maladies. They often have individualistic and immunological basis as also familial tendencies. Warts are included under miasm sycosis. Although warts are local disease they are treated with internal remedy which is based on comprehensive understanding of the patient. Homeopathy has a major role in the treatment of warts. A constituational remedy this selected to eradicates the complaints locally as well as internally thereby providing long lasting relief from complaints.

Warts are the growth of skin resulting from human papilloma virus infection. In general three types of warts are found. A) Common warts appear on any part of the body. B) Plantar warts appear on the sole of feet. C) Genital and anal warts appear on the genitalia and anal region. These are contagious and can spread from direct skin contact. Warts are of diagnostic value to us in distinguishing between different stages of disease. The verruca vulgaris is found in found in children who are suffering with hereditary sycosis, they appear at or about the second dentition. The verruca filiformiscomes as a tertiary lesion is an acquired form of sycosis. The verruca

planajuvenilis is another hereditary form found more or less upon the back of hands and faces of children and young people. They are usually pigmented, disseminated and in irregular unilateral groups.

INCIDENCES/PREVALENCE:

There are few reliable, population based data on the incidence and prevalence of non genital warts. Prevalence probably varies widely between different age groups,

populations and periods of time. Two large population based studies found prevalence rates of 0.84 % in the US and 12.9 % in Russia. Prevalence is highest in children and young adults and two studies in school populations have shown prevalence rates of 12 % in the 4-6 year olds in the UK and 24% in the 16 to 18 year olds in Australia.

AETIOLOGY/RISK FACTORS:

Warts are caused by HPV of which there are over 100 different types. They are most common at sites of trauma, such as the hands and feet and probably results from inoculation of virus into minimally damaged area of epithelium. Warts on the feet can be acquired from walking barefoot in areas where, other people walk barefoot.



HOMEOPATHIC MANAGEMENT:

- Calcareacarbonica Calcareacarbonica is indicated in warts which may be fleshy, horny, painful and offensive patient is usually chilly, lazy and indolent and fearsome.
- Causticum- Causticum is indicated in old, pendunculated warts, suppurating with great sensitivity to touch, hard, horneywarts that bleed easily. Deep burns and their effects. Patient is sympathatic and anxious.
- Dulcamara—Dulcamara is indicated in flat and hard warts located on backs of hands and face. Also indicated in Homeopathic management of large warts patient is worse in cold, damp weather or humidity.
- Natrum Muriaticum: Warts on palms and fingers patient is sensitive, sentimental, reserved and resentful. They also have marked craving for salt.
- 5. Nitric Acidum- NitricAcidum is large fissured warts that itch and sting or bleed upon washing. This remedy is also indicated for people who are anxious about health and worry about cancer often useful for warts that have a horney wall surrounding acentral depression or the more common plantar warts.
- 6. Thujaoccidentalis—The most common homeopathic remedy for various kinds of warts. Thuja is indicated in isolated, jagged warts that smell or bleed easily or mosaic warts on the sole of the foot. It is commonly needed for genital warts. Case.

Abstract- Polycystic Ovarian disease (PCOD) is a complex metabolic, endocrine and reprodu-ctive disorder affecting approximately 5 to 10% of the female population in developed countries it is an emerging health problem in young females characterised by ovarian dysfunction and hyperandrogenium. According to new study in Gynecologic oncology woman having PCOD may be at greater risk of developing some type of cancer if left untreated. Existing information indicates a positive role of homeopathy in PCOD.

The case reported here is that of PCOD in 30 years female who was treated with homoeopathic medicine shows effectiveness of homoeopathy.

Introduction -

Polycystic ovarian disease (PCOD) is a

problem in which a woman hormones are out of balance. It can cause problems with menstrual periods and make it difficult to get pregnant. If it is not treated overtime it can lead to a serious health problems, such as infertility, diabetes and heart disease. The developing countries like China and India, undergoing rapid nutritional transitions and due to westernized diet and lifestyles also indicates 9.13% prevalence. (1) Its clinical characteristics includes hyperandrogenism, Chronic anovulation's, insulin resistance and infertility and it has potential for major metabolic consequences including obesity, diabetes type 2 and Cardiovascular diseases while reproductive features are prominent. No such single criterion is sufficient for diagnosis.

It has been concluded that depression and anxiety are common in PCOD as compared to healthy women. It may often



associate with obesity and metabolic abnormality changes. The depression and anxiety did not show a significant change in PCOD after taking oral contraceptive pills therapy.

Homoeopathy medicines being holistic might help in these aspects which evaluates emotional aspects with disease symptoms through homoeopathic individual case taking for the assessment of quality of life.

Case Report -

A 30 years female consulted for the treatment on 10/08/2019 for the treatment of menstrual irregularities, last 3-4 months menses not appeared, weight gain and mild hair growth on chin and constipation since past 1 year. She was on gynaecologist treatment but did not found quit effective result which leads to her in anxiety day by day. The subject was investigated with ultrasound (USG) of abdomen and pelvis, Thyroid function tests and other necessary hormonal and blood investigations and were found to have an bilateral polycystic ovarian disease.

<u>Personal History</u> - Patient by occupation is a house-wife belonging to middle class socioeconomic family.

Past History - History of- Chicken-pox in childhood.

Family History- Father-Diabetes Mellitus. Mother Hyperaci-dity complaints.

On Examination - No abnormality detected.

Mental Generals-

The patient was looking anxious and hopeful about recovery. The patient is house wife and has 1 girl child of 8 years. She was married 10 years back force fully by parents. She had love affair with someone before her marriage but did not succeed. The patient was looking sad and reserved, dwells on the memories of love affairs. Her husband does not respect her in house and in front of relatives. This hurt her a lot so she did not share her feelings with anyone. She was so disturbed that when someone tries to console her, it leads to irritability. Now she also had a fear of cancer due to the present illness.

<u>Physical General's</u> - The Patient is hot thermally. Her appetite was normal and had an aversion for sweets.

<u>Investigations</u> -Urine pregnancy test -Negative. Thyroid function Test-

All report were in normal range.

Natrum muriaticum 200 two doses 12 hourly and Phytum 4pills TDS for 15 days. Basis of prescription: The similimum was selected on the basis of totality of symptoms. In epertorisation Ignatia, Calc-phos, Carcinosin, Sulphur were coming.

In this Case Natrum muriaticum was coming close to Ignatia but it was selected as it was most suitable to patient's history of chronic grief and its causation which disturbed which disturbed patient mainly. Some exercised for weight reduction was advised to the patient.

Discussion and Conclusion: Homoeopathic medicine are effective in the management polycystic ovarian of disease, as the menstruation of the patient become regular and she was better symptomatically without any conventional medicines.

After going through the above case report study, it is apparent that there is genuine need of more studies in hormonal disorders for the progress of our profession. In clinics we are seeing results, but they are not getting documented due to lack of orientation in documentation. Hence every hornoeopath should take maximum efforts to up bring Hornoeopathy as the most effective and safe treatment.


